Billing Instructions

For claims submission information, refer to the **Claims Submission Guide** posted on www.Magellanofidaho.com, under *For Providers / Getting Paid / Submitting Claims*.

Note on billing modifiers:

- Modifiers must be billed in the order that they appear on the reimbursement schedule to be reimbursed.
Note: Refer to the rate schedule posted on www.Magellanofidaho.com, under *For Providers / Getting Paid* for specific modifier information.

Notes for providers contracted as organizations:

- Providers contracted as organizations must bill license level modifiers for applicable outpatient and community-based services:
 - AF – physician
 - HP – medical psychologist
 - AH – psychologist
 - AJ – master’s level
 - TD – nurse practitioner/physician assistant
- Providers contracted as organizations must insert the license-level modifier in the **first modifier field** and insert additional modifier(s) *in the order that they appear on the reimbursement schedule* in the **subsequent modifier field(s)**.

Notes for providers billing telehealth/virtual care services:

- Providers billing telehealth/virtual care services must submit a rendering address.
- **Telehealth modifier:** Modifiers must be billed in the order that they appear on the provider reimbursement schedule to be reimbursed.
- **Place of service (POS) codes:** All telehealth or audio-only services submitted on an **837p** transaction or **CMS 1500** form must include the appropriate telehealth POS code:
 - If the member is located in their home, bill **POS 10**.
 - If the member is at a location other than their home, bill **POS 02**.

Notes for paraprofessional providers:

- Paraprofessionals must bill services under their supervising practitioner.
 - Providers submit the *supervising provider’s* full name in **Box 33** and NPI in **boxes 33a** and **24J**.
 - Providers submit the *supervised provider’s* full name in **Box 19**.
- Claims must include modifier U1 or UD for appropriate paraprofessional pricing.
 - U1 – Prescribers under supervision
 - UD – Master’s level provider operating under supervisory protocol
